

**2017 Annual Report**  
**College of Education and Health Professions**  
**University of Arkansas**

The College of Education and Health Professions enrolled 5,500 undergraduate and graduate students in 2016-2017 within five academic departments containing 34 different academic program areas offering 44 different degrees. Additionally, the college is home to the university recreation department and 17 research and service units. These students were served by 161 full-time faculty members and nearly 400 staff members located throughout the State of Arkansas. Collectively, the faculty authored over \$24.464,024 in externally funded grants and contracts (89 awards), this was a drop from the previous year. The College leaders raised an additional \$5.9 million in private contributions.

The average ACT scores for entering freshmen held steady at 24.7 and the six year graduation rate for College majors completing at the University climbed to 62.3%. Over 100 students participated in study abroad, a College record, and 320 students participated in Honors programs—down from 363 in 2015-16. All academic units slightly decreased their fall, spring and summer II credit hour production though final summer I numbers will not be reported until mid-August. The Eleanor Mann School of Nursing realized significant enrollment gain of 7.6%

Faculty productivity also increased, with over 700 academic products being produced, up from over 600 products the previous year. These included 9 books, 29 book chapters, 166 refereed articles and among others, 27 invited lectures by COEHP faculty. Faculty racial diversity exceeded 13%, and two-thirds (67%) of the faculty are female. Seven new faculty were hired to begin in 2017, including EMSON Jane Hentzen (Austin, TX) and Kathy Throop ( Bella Vista, AR) as nursing instructors and Angela Stewart (Farmington, AR) and Lori Murray (Tahlequah, OK) as nursing clinical assistant professors. Christine Holyfield as a tenure track assistant professor for counseling in RHRC (State College, PA), Kara Lasater to a tenure track assistant professor in CIED (Lockwood, MO,), Lori Murray as a clinical assistant professor (Tahlequah, OK). Starting in January 2018 will be Robert Davis tenure track assistant professor in HHPR (Oxford, MS.).

HHPR had a significant change to their Ph. D. degree, having combined four separate degrees (doctoral degrees in either Exercise Science, Community Health, Pedagogy or Recreation and Sport management) into a single Ph. D. The new degree was approved and is titled a Ph.D. in Health, Sport, and Exercise Science, with four concentrations (Exercise Science, Health Behavior & Health Promotion, K-12 Pedagogy, and Recreation and Sport Management). This will make the degree more departmental based in that each concentration shares 42 hours of required coursework.

Upon recommendation of a task force including faculty, administrators, and staff a reorganization of the college was acted upon for the 2017-18 academic year. The Associate Dean for Academic Affairs and the Assistant Dean for Health Professions were reconfigured resulting in an Associate Dean for Academic and Student Affairs, and an Assistant Dean for

Research. The Director for the Office of Teacher Education took over most of the Assistant Dean for Education's job duties at the beginning of the 2016-17 year. There were several staffing changes approved in the College for the upcoming year, including three in the Dean's offices. Janet Penner-Williams returned to faculty in the Educational Leadership program of CIED and Ketevan Mamiseishvili was appointed the new Associate Dean for Academic and Student Affairs. Steve Ditmore was appointed one-fourth time to the new position of Assistant Dean for Research. New department heads moving into their positions for 2017-18 include Matt Ganio to Department Head in Health, Human Performance, and Recreation, Michael Hevel to Interim Department Chair of RHRC and Cheryl Murphy to Interim Department Head in Curriculum and Instruction.
